Resources Excelling All Children (REACH) is Sunrise Academy’s plan to meet the needs of students with different learning needs. Parents of children that have been identified as having differentiated learning needs are able apply to have their children placed in the REACH program in order to assist their children in their learning journey. There are two plans available, one for accommodations, and one for additional learning needs. Students in the REACH program are provided with the resources and tools that they need to excel throughout their school life.

Plans Available:

REACH Plan

The REACH Plan provides for specific accommodations for students, such as extra time in testing, and the use of technology in order to meet the individual learner’s needs. A REACH Plan is developed by the school’s REACH coordinator and then shared with the student’s teacher(s) and regular meetings take place to ensure that the child’s needs are being met, and that the REACH Plan is being effectively implemented.

REACH Higher Plan

The REACH Higher plan provides all the benefits of the REACH Plan, plus self-contained learning time with an education specialist and/or a paraprofessional during the school day.

REACH Eligibility, Cost, and Referral

Who can refer a student to the REACH program?

A parent, guardian, teacher, or a member of the school’s REACH team can refer a student to the REACH Program.

Who is eligible for REACH?

Students transferring to Sunrise Academy from another school with an IEP, or equivalent plan are also eligible to be considered for a REACH Plan. Any student with a psychological or medical diagnosis that limits their learning ability is eligible for a REACH plan. Students entering the REACH Program must have a psychological diagnosis conducted by a licensed mental health professional, or a medical condition that limits their ability to learn.

What is the REACH enrollment procedure?

1. Gather documents, such as a psychological/medical report dated within the last 2 years, or an IEP issued or updated in the last 1 year;
2. Apply (make a referral) online at <https://www.mysunriseacademy.org/reach>;
3. Attend a meeting with the school’s REACH coordinator;
4. Once accepted into REACH, make the first month’s payment for the REACH Plan;
5. REACH Plan is effective from the first day of the next month.

What is the cost of REACH?

The cost will vary depending upon the type of REACH Plan selected, and the cost of REACH is in addition to other tuition and fees. There is a \$25 application fee due at the time of application to the REACH Program. Program fees must be paid promptly each month to ensure continued enrollment in the REACH Program. For the current academic year, the fees are as followed:

REACH Plan Type	Fee Due Frequency	Amount
REACH	1 st of Each Month <i>No Fee Due in June or July</i>	\$100
REACH Higher	1 st of Each Month <i>No Fee Due in June or July</i>	\$200

Can I un-enroll my child from REACH?

You can un-enroll your child from REACH at any time before the next month’s bill is due. If you wish to un-enroll your child, please send a written request to admissions@mysunriseacademy.org stating your request and it will be processed within 1-2 business days.
